Mr. Embry,

At your request, our office completed an Administrative Review of vending machine operations conducted in various County locations.

A spreadsheet is attached identifying the locations of the vending machines, identification of the operators, commission structure (or lack thereof), and whether an operating agreement exists.

Our office found there is only one official agreement for stand-alone operation of vending machines in the County. C19-2827-BCC covers vending in the Crestview Courthouse and was amended to add machines in the EMS Training Center (2110 PJ Adams Pkwy). The Airport and TDD Convention Center have vending operations that are tied to larger Master Concession agreements that include vending machines as part of the agreement. As noted in the spreadsheet, the balance of the locations do not have operating agreements. Some locations do generate revenue in the absence of an operating agreement. Our review yielded locations that have no operating agreement and are not generating County or department revenue in those locations. Research found that vending operations are bought out by different vendors and the County is not notified of changes and is unaware of who services the machines, due to a lack of an operating agreement.

Several departments have internal self- funded employee-only vending operations with no vendor attachment. One of the vendors, Quality Snacks, mentioned several locations being serviced that are not included on the spreadsheet as they were not public facing machines. The bus barn was mentioned as an example.

The Corrections department currently has vending operations but is moving to a different platform that will eliminate vending machines, so we did not pursue their existing commission structure. We verified with the current vendor the existence of vending machines at the location.

A review of payments received from the existing vendors indicates sporadic payments that do not always include every machine serviced at a location, but we did not evaluate the

possible lack of payment or lack of regular payment that occur due to low revenue machines. Our review found that no individual is responsible for evaluating the vendor payments for any type of sufficiency or contract compliance.

We recommend the County either amend the existing County vending contract to include all locations with public facing vending machines so only one vendor is responsible for all locations for monitoring and tracking purposes or rebid the contract to potentially increase the revenue percent through competitive bidding.
