Subject: Report on Counts of Clerk Change Funds

We conducted surprise cash counts of change funds for all Clerk divisions on May 7<sup>th</sup> and 8<sup>th</sup>, 2019. The purpose of these counts is to periodically verify the existence and amounts of these funds, to observe, to the extent possible, the cash collection procedures in place and to review the physical safeguards for protecting funds at these locations. This review does not constitute a full review of all cash collection procedures or physical safeguards of cash. Such would be the subject of a separate engagement.

We compared amounts recorded in the General Ledger as change funds to the amounts held at the various collection points. We are pleased to report that the results of the unannounced cash counts were exceptional with no variances noted. The fact that no discrepancies were noted speaks to the quality and dedication of the staff and managers in these positions.

We would like to thank the management and staff at the various collection locations for the assistance and cooperation extended to us during our cash counts.
