**ORDER DETERMINING CONFIDENTIALITY OF AND SEALING COURT
RECORDS**

THIS CAUSE was brought before this Court upon Petitioner's Motion to Determine Confidentiality of Court Records and Seal, there being no objection by the Respondent, and this Court being otherwise fully apprised of the premises herein, finds as follows:

1. This is a Petition for Injunction for Protection Against Domestic Violence file.
2. Based upon the request to take judicial notice in the file, the grounds under *Fla. R. Gen. Prac. & Jud. Admin. 2.420(c)(9)(A)* have been met in determining the information is confidential. Petitioner's Composite Exhibit 1 – Composite Videos and Petitioner's Exhibit 5-11, Photos of Child, are determined to be confidential.
3. The degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in *Fla. R. Gen. Prac. & Jud. Admin. 2.420(c)(9)(A)* and there are no less restrictive measures available to protect the interests set forth in *Fla. R. Gen. Prac. & Jud. Admin. 2.420(c)(9)(A)*. See *Fla. R. Gen. Prac. & Jud. Admin. 2.420(c)(9)(A)-(C)*.

IT IS ORDERED AND ADJUDGED as follows:

- A. The Motion to Determine Confidentiality of Court Records and Seal is granted.
- B. Petitioner's Composite Exhibit 1 "Flash Drive (Composite Videos)" and Petitioner's Exhibits 5-11 "Photo of Child" shall be sealed from access to the public.
- C. Ms. Cassie McDonald Reed, Esq., Counsel for Petitioner, Petitioner, Mr. Curtis W. Brannon, Esq., Counsel for Respondent, and Respondent shall be permitted to view the confidential information and shall be permitted to purchase any certified copies of documents from the Court file.

- D. The Clerk of the Court is directed to publish the order in accordance with subdivision *Fla. R. Gen. Prac. & Jud. Admin. 2.420(e)(4)*.
