BAIL BOND AGENT REGISTRATION**

Agents are required to register and file a certified copy of the power of attorney with both the Clerk and Sheriff by April 1st of each odd-numbered year in the county in which the agent resides. (FS 648.42) The Clerk may not permit registration unless the agent is currently licensed and appointed by the department of Financial Services. An agent may also register in any other county.

1. To give written notice to the clerk within 10 working days of any change in agent's principal business name, address, phone number or email address, and for any change in name, home address, email address or phone number for him/herself. §648.421, Fla Stat.
2. Any licensed agent who is authorized and appointed to sign the appointed agent's name to bonds must file a copy of the power of appointment given to the appointed agent from each insurer with the Sheriff and Clerk in the county where the appointed agent resides and with the Department of Financial Services. §648.43, Fla. Stat.
3. All agents that are corporations must register their corporate name and any fictitious name ["Doing Business As" (D/B/A)] with the Department of State, Division of Corporations and with the Clerk. §865.09, Fla. Stat.
4. By signing this contract, you authorize electronic notification of court notifications and forfeiture notices per §903.26(2)(a), Fla Stat.
