**ORDER GRANTING MOTION TO DETERMINE
CONFIDENTIALITY OF COURT RECORDS**

THIS MATTER having come before the Court on Monday, December 29th, 2025, on Respondent's Motion to Determine Confidentiality of Court Records filed December 28th, 2025, and the Court having reviewed the Respondent's Motion to Determine Confidentiality of Court Records, hearing argument of counsel and being otherwise fully advised in the premises, the Court makes the following findings of fact:

1. Pursuant to Fla. Rule 2.420(e)(4)(A) this Order is entered into in a matter identified as a dissolution of marriage action.
2. The Court finds that to protect against identify theft of the parties, to protect the privacy of the parties, and in consideration of the unique sensitivities of the case, this matter shall be confidential pursuant to Fla. Rule 2.420(e)(4)(B).

3. The Court finds that the names of both parties shall be sealed pursuant to Fla. Rule 2.420(e)(4)(C). The subject case shall be reflected and referred to as *Confidential v. Confidential*.

4. The entire case file of this matter is confidential and shall be sealed in compliance with Fla. Rule 2.420(e)(4)(D) and Fla. Rule 2.420(e)(4)(E).

5. Pursuant to Fla. Rule 2.420(e)(4)(F), no person or persons, excepting the parties and their counsel of record, shall be permitted to view the entire case file in this matter or any portion of the case file, inclusive, *inter alia*, of the discovery, pleadings, motions, orders, and marital settlement agreement in this matter.

6. Pursuant to Fla. Rule 2.420(e)(4)(G) there are no other less restrictive measures to protect the privacy of the parties. This matter shall be confidential in perpetuity.

ORDERED AND ADJUDGED as follows:

1. The Respondent/Husband's Motion to Determine Confidentiality of Court Records is hereby **GRANTED**.

2. Pursuant to Fla. Rule 2.420(e)(4)(H) the Clerk of Court is directed to publish this Order in accordance with subdivision (e)(5), specifically, including that within 10 days following the entry of this Order, the Clerk of Court shall post a copy

of this Order on the Clerk's website.
